Regarding Summer Beach Operational Plans

SUMMARY

THIS IS AN INFORMATION ITEM ONLY. NO ACTION IS REQUIRED ON THE PART OF THE COMMITTEE OR THE CITY COUNCIL.

BACKGROUND

Each year, visitors vacationing from around the world visit San Diego's beaches and bays, with the majority visiting between the start of Spring Break in March through the Labor Day holiday in September.

GOALS and OBJECTIVES

The goal of the San Diego Police Department is to ensure a peaceful, orderly environment for all persons who come to the beach and bay areas; facilitate the smooth flow of traffic in and around the area; and to rapidly and efficiently solve problems. Police personnel will enforce applicable State laws and City ordinances.

Enforcement is designed to hold the offender accountable and to encourage compliance. In order to meet these objectives officers will maintain a high profile, high enforcement posture. However, officers always have discretion to warn offenders as opposed to issuing a citation.

STAFFING

The majority of the beaches and bays are located within Northern Division. Ocean Beach is located within Western Division.

Northern Division recommended daily staffing (Beginning in May)

<u>Holiday Enhanced Staffing for Memorial Day (May 24 - 27 FSSM) and Labor Day (August 30 - September 2 FSSM)</u>

Staffing will be enhanced on Friday, Saturday, Sunday and Monday for both Memorial Day and Labor Day weekends to address activity along the beaches and bays.

Staffing will be enhanced during the evening hours on Friday, Saturday and Sunday for both Memorial Day and Labor Day to address activity in the Entertainment District along Garnet Avenue and Mission Blvd.

This staffing plan proved successful last year and is anticipated to work well over the Memorial Day Holiday weekend this year. The enhanced staffing numbers will be adjusted depending on weather conditions and crowd estimates.

July 4th Holiday Plans (July 3-4, WTh)

The 4th of July holiday is the largest and busiest event of the year for not only the beach community, but the City of San Diego as well. Crowd estimates of more than one million people will fill the beaches, bays and parks. Historically, crowds have begun to gather as early as the night before the holiday. People gather to picnic, party and view area fireworks shows. At the end of the fireworks displays, everyone who gathered in the area will attempt to leave at the same time, with the majority of them leaving by vehicle.

To best facilitate our goals and objectives as stated above, the Incident Command System will be utilized over the July 4th holiday. The Unified Command Center will be located at the De Anza Resort. Two secondary Command Posts (Belmont Park and Reed Avenue) located throughout the beaches and bays and a separate Command Post in Ocean Beach will support Beach Command. (Other areas will be policed by officers assigned within specific geographical boundaries. Fanuel Park CP for example will have BET officers assigned there and all along Sail Bay through Crown Point Shores.) Beach Command will monitor police activity occurring

within the jurisdiction of each area and coordinate a multi-division response to incidents requiring extensive police resources.

The basic objective of each Command Post is to provide a centralized location where operations can be coordinated from and deter criminal activity by providing a substantial police presence.

Staffing will be enhanced for the July 4th holiday starting on Wednesday, July 3rd and continuing through Sunday, July 7th to respond to calls for service due to the anticipated heavier crowd counts. The enhanced staffing will begin early in the morning and continue throughout the day. Enhanced staffing will also be utilized during the evening hours in the entertainment district along Garnet Avenue and Mission Boulevard. This staffing plan proved successful last year. The enhanced staffing numbers will be adjusted depending on weather conditions and crowd estimates.

Participating in the coordinated response are personnel from the following San Diego Police Units:

Personnel will be deployed both in uniform and in plain clothes. They will be on foot, bicycles, ATV's, cars, boats, motorcycles and in the air.

OUTREACH

Each year the public education has been progressively better. Today the public has a much better understanding of the beach rules. News releases will be sent to all local media and Los Angeles radio, television and print media. News releases to major colleges in California,

Arizona, Oregon, Texas and Nevada will be sent prior to all the major holidays. Included in the news releases and interviews will be reminders regarding beach rules, traffic issues and laws regarding the consumption of alcohol.

Northern Division's pilot Facebook page will also be used to disseminate information to the public.

CONCLUSION

All of these combined efforts and resources have proven successful in providing a safe and enjoyable environment for everyone who visits our beautiful beaches and bays.
