## REQUESTED ACTION:

1) Approve amendments to Municipal Code Section 22.0101: Permanent Rules of Council; Rule 1.3, Rule 2.2, and Rule 2.6.2

### STAFF RECOMMENDATION:

Approve recommended revisions to the requested Municipal Code Sections clarifying the Non-Agenda Public Comment process to be used during regularly scheduled City Council Meetings

#### **SUMMARY:**

Brown Act Section 54954.3(a) states, "every agenda for regular meetings shall provide an opportunity for members of the public to directly address the legislative body on any item of interest to the public...that is within the subject matter jurisdiction of the legislative body." Furthermore, Section 54954.3 (b) clarifies, "the legislative body of a local agency may adopt reasonable regulations to ensure that the intent of subdivision (a) is carried out, including, but not limited to, regulations limiting the total amount of time allocated for public testimony on particular issues and for each individual speaker."

Charter Section 14 states, "The Council shall determine its own rules and order of business." To that end, San Diego Municipal Code Section 22.0101: Permanent Rules of Council outlines the Rules of the Council and the proper legal procedure and protocol to conduct the business of the City Council. Recognizing the current practices of the Council with an eye toward efficiency and transparency, the following revisions and clarifications to the Permanent Rules of Council regarding Non-Agenda Public Comment are proposed:

## PERMANENT RULES OF COUNCIL

#### 1.3. Place

Regular Council meetings shall be held in the Council Chambers of the City Administration Building, Community Concourse, in the City of San Diego, California. In addition thereto, the Council shall may also hold regularly scheduled night Council meetings starting no earlier than 6:00 p.m. in the Council Chambers of the City Administration

Building or in various community facilities throughout the City of San Diego. Such night Council meetings will be at the discretion of the Council President scheduled at least six times during each legislative calendar year, with the specific date, time, and location of each meeting to be established by resolution of the Council. In the event a regular meeting shall fall on a legal holiday, the meeting may be held on the next business day.

## 2.6. Non-Agenda Public Comment

2.6.2. Speakers shall be limited to three minutes each and comments shall be limited to three minutes per subject regardless of the number of people in attendance. Anyone desiring to speak shall reserve time at the meeting by filing a written request with the Clerk. Speakers will be called in the order reserved within the available time. In order to ensure that the Council has time to consider all agenda items, Non-Agenda public testimony on particular issues and for each individual speaker will be as follows:

- (a) Each speaker must file a written request (speaker slip) with the Clerk at the meeting at which the speaker wishes to speak. Speaker slips may not be turned in prior to the meeting date or after completion of Non-Agenda Public Comment.
- (b) Each speaker will be limited to two minutes. If there are eight or more speakers on a single issue, the maximum time for the issue will be 16 minutes. The order of speaking generally will be determined on a first-come first-served basis, however, priority may be given to speakers who have not addressed the legislative body during Non-Agenda Public Comment at the last regularly scheduled Council meeting.
- (c) Non-Agenda Public Comment is limited to 30 minutes during the morning session of the Tuesday Council meeting per Rule 2.2. Any remaining speakers will be given an opportunity to speak after Council concludes the other agenda items for that day.

Currently, any public member that attends a City Council meeting to speak on Non-Agenda Public Comment may wait an hour or more to address the Council, depending on the number of proclamations and consent items being discussed. The public would now be able to address the Council on either Monday or Tuesday during times that may be more predictable and convenient for them. On Mondays the public would have an opportunity toward the end of the agenda, and on Tuesdays Non-Agenda Public Comment would be taken almost time certain at 10 a.m. prior to any other business scheduled. The proposed changes as outlined above would create more opportunities, as well as a time efficient process for the public to address the Council on items not listed on the agenda.

In addition, from a review of the last six months there has been no substantial increase of Non-Agenda Public Comment speakers in attendance to address the Council during the scheduled 6p.m. night meetings. In an effort to be more efficient with city resources and with the substantial increase of opportunities to the public to address the Council through the means proposed here, staff suggests that night meetings be held at the discretion of the Council President. These proposed amendments would allow the legislative body, per the Brown Act, to adopt regulations to assist in processing comments from the public in a fair and equitable way with the interest of the public in mind.

## FISCAL CONSIDERATIONS:

It is currently estimated to cost at least \$4,000 -\$18,000 a year to hold night meetings. This estimate varies depending on several factors including what item is being docketed and whether the item is controversial and if the meeting is being held on site in Council Chambers or off-site in the community.

## PREVIOUS COUNCIL and/or COMMITTEE ACTION:

Certain issues regarding Non-Agenda Public Comment were previously heard in Closed Session on October 21, 2014.
