General Plan

**Public Outreach
January 2003 - November 2007**

The City of San Diego's (City) public outreach for the General Plan officially began after adoption of the Strategic Framework in 2002. Since January of 2003, Planning staff members have scheduled workshops and presentations at meetings held by Community Planning Groups (CPG), the Community Planners Committee (CPC [composed of members of each of the CPGs]), and numerous stakeholder and interest groups. Planning staff has also held public forums and technical advisory meetings, as well as reported to meetings of the full San Diego City Council, the Land Use and Housing Committee of the City Council, and the Planning Commission. The public and stakeholders had opportunities to both receive information and provide input on the General Plan at each of these public meetings.

Planning staff has held over 250 public meetings on the General Plan since January 2003. The following is a summary of these meetings.

Community Planning Groups

The CPGs in San Diego were formed through Council Policy to advise the City in the preparation, adoption, and implementation of the General Plan and Community Plans, as they pertain to the plan area of each group. They are an integral part of planning in San Diego. Staff has presented the General Plan to all of the City's officially recognized CPGs to receive input at 90 meetings.

In 2003, staff presented the General Plan to the following CPGs: Normal Heights, City Heights, Eastern Area, Skyline-Paradise Hills, Greater Golden Hill, Carmel Mountain Ranch, Scripps Ranch, Southeastern, North Park, San Ysidro, Otay Mesa, Clairemont Mesa, Kearny Mesa, Mira Mesa, Encanto, Linda Vista, San Ysidro, Miramar Ranch North, Ocean Beach, Uptown, College Area, Navajo, Mission Beach, Sabre Springs, Pacific Beach, La Jolla, City Heights, Normal Heights, Serra Mesa, and Clairemont Mesa

In 2004, General Plan staff attended the following CPGs: Del Mar Mesa, Carmel Valley, Midway, Otay Mesa Nestor, Mira Mesa, Torrey Hills, Skyline Paradise Hills, North Park, Encanto, Uptown, and Mission Beach

In 2005, the General Plan was presented to the following CPGs: City Heights, Miramar Ranch North, Mission Valley, La Jolla, Carmel Valley, Eastern Area, College Area, Greater Golden Hill, Midway, Carmel Mountain Ranch, Del Mar Mesa, Encanto, North Park, Mira Mesa, Clairemont Mesa, Mission Beach, Kearny Mesa, Centre City, Sabre Springs, Linda Vista, Ocean Beach,

Rancho Peñasquitos, La Jolla, San Pasqual/Lake Hodges, Scripps Ranch, Normal Heights, Skyline/Paradise Hills, Uptown, Kensington, Old Town, Otay Mesa/Nestor, Torrey Pines, Southeastern, San Ysidro, University City, Otay Mesa, Tierrasanta, Peninsula, Rancho Bernardo, Serra Mesa, Navajo, Torrey Hills, and Pacific Beach.

Community Planners Committee

The CPC provides a forum to discuss citywide planning issues. Council Policy 600-24 designates each CPG chair to also be the group's representative at the CPC. The meetings often include presentations by City Planning Department staff and other speakers on topics of interest to the CPC. Positions taken by CPC about important issues provide a key link with decision makers at City Hall and in the various City Departments. In addition, the CPC has formed subcommittees to review various issues in depth, and has made recommendations of great value to City decision makers.

Planning staff provided presentations and solicited input on the General Plan at 16 CPC meetings and 12 CPC subcommittee meetings as follows:

Forums

In 2003 and 2004, Planning staff held forums on General Plan topics of citywide interest. Each meeting featured a panel of speakers with expertise in the forum topic. Over 350 people attended the forums. Forum topics were as follows:

- “Economic Prosperity For All: How Do We Get There?”
- “Breaking the Gridlock: Moving People to New Mobility Choices”
- “Conservation: What on Earth Are We Doing? How Today's Decisions on Land Use, Water & Energy Affect Our Future”
- “Commercial Development: Dollars and Sense: The Future of Commercial Development in San Diego”
- “San Diego's Great Balancing Act: Exploring Creative Recreational Choices for the Future”
- “Mission Impossible: Balancing Public Facilities Needs and the Demand for More Housing”

Pilot Village Program Workshops

The Pilot Village program serves as a catalyst for implementing the City of Villages strategy detailed in the Strategic Framework Element and the General Plan update. It is designed to build working examples that demonstrate how villages can benefit communities citywide. Planning staff have held approximately 34 meetings on the Pilot Village program since January of 2003. About half of these meetings were with the applicants and the remaining were information presentations to the public. The City had two public hearings with both the Planning Commission and the City Council in January and February of 2004 to select the pilot villages through a competitive process.

Public Hearings and Workshops: City Council, Land Use and Housing Committee of the City Council, and the Planning

Since 2003, planning staff has scheduled workshops and hearings on the General Plan update with elected and appointed decision makers. This includes eight meetings of the Land Use and Housing Committee (LU&H), ten Planning Commission meetings, and two joint Planning Commission and LU&H meetings, and one joint Planning Commission and Park and Recreation Board Meeting. These meetings have been televised and open to the public.
