Comments received after the start of the Planning Commission will not be read into the record but, will be distributed to the Commission for consideration and made part of the meeting record. If you submit more than one form, only one will be read into the record.

As a property owner, tenant or person who has requested notice, you should know that the Planning Commission will hold a public hearing to consider **recommending** approval, conditional approval, or denial to the City Council of an amendment to the North Park Community Plan and General Plan and a Rezone in the North Park Community.

This project includes the following amendment: Redesignate 3.5 acres located between Florida Street and the parallel alley east of Florida Street and between Upas Street and Cypress Avenue, from Residential Low 5-9 dwelling units per acre (du/ac) to Residential Medium-High 30 - 44 du/ac.

The corresponding rezone action associated with the community plan amendment would affect the same 3.5 acres within the approximately 2,258-acre North Park Community Planning Area (this excludes streets and public rights-of-way) and include: Rezone 3.5 acres from RS-1-7 (up to 9 du/ac) to RM-3-7 (up to 44 du/ac).

These land use actions require approval of a General/Community Plan Amendment and associated rezone. A revised Addendum (dated April 30, 2020) to the Environmental Impact Report No. 380611 / SCH No. 2013121076 for the project in accordance with The California Environmental Quality Act (CEQA) and State CEQA Guidelines covering this activity has been prepared and has been placed on the City of San Diego website at: http://www.sandiego.gov/planning/programs/ceqa/index.shtml

The decision to approve, conditionally approve, modify, or deny the amendment to the North Park Community Plan and General Plan and associated rezone will be made by the City Council at a future public hearing. A separate notice of public hearing will be provided 10 business days prior to the City Council hearing for this item.

If you wish to challenge the City's action on the above proceedings in court, you may be limited to addressing only those issues you or someone else have raised at the public hearing described in this notice, or written in correspondence to the City at or before the public hearing. If you have any questions after reviewing this notice, you can call the City Project Manager listed above.
