If you submit more than one form, only one will be read into the record.

As a property owner, tenant, or person who has requested notice, please be advised that the Planning

Commission will hold a public hearing to **recommend** approval, conditional approval, or denial to the City Council of an application for General Plan and Community Plan Amendment to the Rancho Penasquitos Community Plan to change street system classification, circulation element, and transportation phasing plan of an approximately 1.3-mile segment of Black Mountain Rd., between Twin Trails Dr. and southern community boundary adjacent to Los Penasquitos Cyn. Preserve, from Prime Arterial (6-lane) to Major Arterial (4-lane).

The decision to approve, conditionally approve, modify or deny the General Plan and Community Plan Amendment will be made by the City Council at a future public hearing. You will also receive a notice of the City Council public hearing.

If you wish to challenge the City's action on the above proceedings in court, you may be limited to addressing only those issues you or someone else have raised at the public hearing described in this notice, or written in correspondence to the City at or before the public hearing. If you have any questions after reviewing this notice, you can call the City Planner listed above.
