As a property owner, tenant, or person who has requested notice, please be advised that the Planning Commission will hold a public hearing to **recommend** approval, conditional approval, or denial to the City Council of an application to allow for the construction and operation of a 54,476-square-foot (SF), two-story church/sanctuary building and a 71,010 SF, two-level parking garage and surface parking areas on an approximately 5.99-acre site. The church use includes a 900-seat sanctuary space with accessory uses (i.e., Sunday school classrooms, offices, and a multi-purpose room/gym), and various site improvements, such as a traffic signal, hardscape improvements, landscaping, and utility connections. The project site is currently unaddressed and undeveloped, located northeast of the College Avenue/Interstate 8 interchange, south of Del Cerro Boulevard, within the RS-1-7 Base Zone, the Airport Land Use Compatibility Overlay Zone (Montgomery Field), Airport Influence Area (Montgomery - Review Area 2), Sustainable Development Area, Parking Standards Transit Priority Area (Campus) within the Navajo Community Plan area.

Program (MMRP), has been prepared for the project in accordance with State of California Environmental Quality Act (CEQA) Guidelines. The EIR found potentially significant impacts in the areas of Biological Resources, Historical Resources, Noise, and Tribal Cultural Resources. An MMRP would be implemented that would reduce impacts to below a level of significance associated with Biological Resources, Historical Resources, Noise, and Tribal Cultural Resources.

The decision to approve, conditionally approve, modify, or deny the certification of the EIR, adoption of the MMRP; General Plan Amendment, Community Plan Amendment, Planned Development Permit, Site Development Permit, Tentative Map and Easement Vacations will be made by the City Council at a future public hearing. You will also receive a notice of the City Council public hearing.

This item may begin at any time after the time specified. Any interested person may address the Planning Commission to express support or opposition to this issue. Time allotted to each speaker is determined in the discretion of the Chair and, in general, is limited to three (3) minutes. Public comment can be in person, via the webform, written testimony, or through teleconference and video conference options.

In lieu of in-person attendance, members of the public may also participate and provide comment via telephone, ZOOM, using the Planning Commission webform, or via U.S. Mail of written materials, as follows:
