As a property owner, tenant, or person who has requested notice, please be advised that the Planning Commission will hold a public hearing to **recommend** approval, conditional approval, or denial to the City Council for an application for a Community Plan Amendment, Planned Development Permit to amend Planned Commercial Development No. 87-0639, and Rezone from RM-1-2 to RM-4-10 to construct a four-story, 70,595 square-foot, 50-unit multi-family residential building over an existing two-level parking structure at a site located at 10211 Rancho Carmel Drive within the Carmel Mountain Ranch Community Plan area. The project requests a Community Plan Amendment to change the existing land use designation from low-medium density to high density residential uses. Of the 50 residential units, 35 units will be market rate units, and 15 units will be designated as affordable for low to moderate income households. The 0.46-acre site is in the Airport Land Use Compatibility Overlay Zone (MCAS Miramar), the Airport Influence Area Overlay Zone (MCAS Miramar - Review Area 2), the Residential Tandem Parking Overlay Zone, the Parking Standards Transit Priority Area, and the Transit Priority Area.

The decision to approve, conditionally approve, modify or deny the project will be made by the City Council at a future public hearing. You will also receive a notice of the City Council public hearing.

This project is within the scope of Negative Declaration (ND) No. 90-0687, adopted on October 26, 1990, and as amended in Addendum No. 648597 to ND No. 90-0687. This Addendum to the ND adequately describes the activity for the purposes of CEQA.

If you wish to challenge the City's action on the above proceedings in court, you may be limited to addressing only those issues you or someone else have raised at the public hearing described in this notice, or written in correspondence to the City at or before the public hearing. If you have any questions after reviewing this notice, please contact the City Project Manager listed above.
