

RESOLUTION No. 186048

BE IT RESOLVED by the Council of The City of San Diego as follows:

That the deed of BRAVEN R. SMILLIE and ELSIE LOUISE SMILLIE, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date September 1, 1965, conveying to said City an easement and right of way for street purposes through, over and across a portion of Lot 27 in Block 15 of DEL MAR HEIGHTS, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 157, filed in the office of the County Recorder of said San Diego County, July 8, 1887, as more particularly described in said deed, be, and the same is hereby accepted on the conditions therein expressed; and the lands therein conveyed are hereby set aside and dedicated as and for a public street and the same are hereby named DEL MAR HEIGHTS ROAD.

That the City Clerk of said City is hereby authorized and directed to file the foregoing deed for record in the office of the Recorder of said San Diego County.
