

RESOLUTION NO. 186276


BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

1. That the City Manager be, and he is hereby authorized to enter into an agreement with Foster & Kleiser in the amount of Five Thousand Dollars (\$5,000.00) for the use of signs in connection with the construction of the Stadium for an 18-month period, said signs to be painted once and repainted twice by Foster & Kleiser and payments therefor shall be made on invoice as costs of painting are incurred.

2. That the said sum of Five Thousand Dollars (\$5,000.00) be, and it is hereby authorized to be expended out of the Stadium Administrative Expense account of the 245 Fund, solely and only for the cost incurred for the signs, said 245 Fund to be reimbursed out of the proceeds of the revenue bond sale of the San Diego Stadium Authority.

## CERTIFICATION OF UNENCUMBERED BALANCE


