

# RESOLUTION No. 186335

BE IT RESOLVED by the Council of The City of San Diego as follows:

That the verbal appeal of Helena G. Peterson, from the Street Superintendent's Assessment No. 3314, made to cover the costs and expenses of the work of paving and otherwise improving SPRINGFIELD STREET, PUBLIC RIGHTS OF WAY IN LOT 4 and LOT 19, HIGHDALE ADDITION; and MALLARD STREET, under Resolution of Intention No. 183259, adopted March 30, 1965, be, and it is hereby overruled and denied and all other appeals, written or verbal, are hereby overruled and denied.

The Street Superintendent's Assessment No. 3314 is hereby confirmed and approved, and the Street Superintendent of said City is hereby authorized and directed to attach his warrant thereto and issue the same in the manner and form provided by law. Said warrant shall bear date of this order. The Street Superintendent of said City shall record in the office of said Superintendent said warrant, diagram and assessment, and immediately thereafter, shall record a notice of assessment, as provided for in Section 3114 of the California Streets and Highways Code.
