

RESOLUTION No. 186337

BE IT RESOLVED by the Council of The City of San Diego as follows:

That the appeal of William L. Howell and Clarabel R. Howell, filed under Document No. 695778, from the Street Superintendent's Assessment No. 3316, made to cover the costs and expenses of paving and otherwise improving the ALLEY, BLOCK C, REDLAND GARDENS, under Resolution of Intention No. 183124, adopted March 16, 1965, be, and it is hereby overruled and denied and all other appeals, written or verbal, are hereby overruled and denied.

The Street Superintendent's Assessment No. 3316 is hereby confirmed and approved, and the Street Superintendent of said City is hereby authorized and directed to attach his warrant thereto and issue the same in the manner and form provided by law. Said warrant shall bear date of this order. The Street Superintendent of said City shall record in the office of said Superintendent said warrant, diagram and assessment, and immediately thereafter, shall record a notice of assessment, as provided for in Section 3114 of the California Streets and Highways Code.
