

RESOLUTION NO. 186374

WHEREAS, The City of San Diego is in the process of acquiring land required for a multipurpose stadium; and

WHEREAS, the City and San Diego Pipeline Company, a California corporation, desire to enter into an agreement whereby the City agrees to purchase a portion of Lot 42 of Rancho Mission of San Diego, County of San Diego, State of California, as shown on Record of Survey Map No. 6289, and as described in "Exhibit A" of said agreement, for said purpose; and

WHEREAS, the terms and conditions of said purchase are more particularly set forth in said agreement; and

WHEREAS, said portion of said Lot 42 consists of 13.5 acres and has a fair market value of \$340,000.00; and

WHEREAS, the purchase of said property is in the public interest and the sale price of \$340,000, plus costs of title and escrow charges in the amount of \$3,200.00, for a total sale price of \$343,200.00 should be authorized to be expended out of Capital Outlay Fund 245; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be, and he is hereby empowered to execute, for and on behalf of said City, an agreement with San Diego Pipeline Company, a California corporation, covering the purchase by City of a portion of Lot 42 of Rancho Mission of San Diego for the purpose of a multipurpose stadium, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 696158.

2. That the expenditure of \$343,200.00 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of acquiring fee title to a portion of Lot 42 of Rancho Mission of San Diego, County of San Diego, State of California, as shown on Record of Survey

Map No. 6289, required by City for a multipurpose stadium.

3. That the City Clerk of said City be, and he is hereby authorized and directed to deliver a certified copy of this resolution and said agreement to the Property Director of said City for completion of the transaction.
