

RESOLUTION No. 186393

BE IT RESOLVED by the Council of The City of San Diego as follows:

That the deed of SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, executed in favor of The City of San Diego, bearing date January 14, 1966, conveying to said City an easement and right of way for street purposes through, over and across a portion of Pueblo Lot 1187 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to map thereof made by James Pascoe in 1870, a copy of which was filed in the office of the County Recorder of said County of San Diego, November 14, 1921, and is known as Miscellaneous Map No. 36, as conveyed to San Diego Gas & Electric Company, a corporation, by Deed recorded November 28, 1956, in Book 6360 at page 380 as Document No. 168115 of Official Records of said County of San Diego, as more particularly described in said deed, be, and the same is hereby accepted on the conditions therein expressed; and the lands therein conveyed are hereby set aside and dedicated as and for a public street and the same are hereby named MURRAY CANYON ROAD.

That the City Clerk of said City is hereby authorized and directed to file the foregoing said deed for record in the office of the Recorder of said San Diego County.
