

RESOLUTION No. 186395

BE IT RESOLVED by the Council of The City of San Diego as follows:

That the deed of DALE F. TOWNSLEY and FRANCES I. TOWNSLEY, husband and wife, as joint tenants, executed in favor of The City of San Diego, bearing date January 26, 1966, conveying to said City an easement and right of way for street purposes through, over and across a portion of Lot 9, Block 5, Encanto Heights, according to Map thereof No. 1063, as filed in the Office of said San Diego County Recorder on June 6, 1907, as more particularly described in said deed, be, and the same is hereby accepted on the conditions therein expressed; and the lands therein conveyed are hereby set aside and dedicated as and for a public street and the same are hereby named STORK STREET.

That the City Clerk of said City is hereby authorized and directed to file the foregoing said deed for record in the Office of the Recorder of said San Diego County.
