BE IT RESOLVED by the Council of The City of San Diego as follows:

That the deed of KASMIR J. TARNOWSKI and ANNE T. TARNOWSKI, husband and wife, as to an undivided one-half interest; and GEORGE H. DALTON and LORRAINE C.
