

RESOLUTION No. 185949

BE IT RESOLVED by the Council of The City of San Diego as follows:

That the deed of KASMIR J. TARNOWSKI and ANNE T. TARNOWSKI, husband and wife, as to an undivided one-half interest; and GEORGE H. DALTON and LORRAINE C. DALTON, husband and wife, as joint tenants, as to an undivided one-half interest, executed in favor of The City of San Diego, bearing date December 28, 1965, conveying to said City easements and rights of way for slope and street purposes, through, along and across portions of Lots 1 and 2, Block 14, and Lots 14 and 15, Block 11 of Floral Terrace, according to Map thereof No. 1635, filed May 11, 1914 in the office of the San Diego County Recorder, and Lots 8 and 9, Block 100, Pacific Beach, according to Map thereof No. 933 filed November 9, 1904, in the office of the San Diego County Recorder, as more particularly described in said deed, be, and the same is hereby accepted on the conditions therein expressed.

That the City Clerk of said City is hereby authorized and directed to transmit the said deed to the Property Department for recording and further disposition.
