BE IT RESOLVED by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City a Lease Agreement with AERIAL CROP SERVICE INC., a California corporation, as lessee, leasing Building No. 3, Brown Field, containing approximately 2,640 square feet floor space, plus 21,400 square feet of adjacent aircraft tie down and parking area, for a term of one year ending July 31, 1966, for the purpose of a fixed base aircraft operation and aerial crop dusting service, under the terms and conditions set forth in the form of Lease Agreement on file in the office of the City Clerk as Document No. 694715.
