BE IT RESOLVED by the Council of The City of San Diego as follows:

That the bid of Chula Vista Blueprint Co. for furnishing the City of San Diego with an INITIAL ORDER OF AN ESTIMATED 300 SETS OF STADIUM BLUELINE REPRODUCTIONS AND AN ESTIMATED 100 ADDITIONAL SETS as may be required for the one year period beginning February 15, 1966 through February 14, 1967 at a cost of \$0.012 per sq. ft. plus \$0.40 per sepia sheet required for reproduction; terms 3% 10 days, plus sales tax is hereby accepted; and the contract for same is hereby awarded to Chula Vista Blueprint Co.

BE IT FURTHER RESOLVED that the City Manager is hereby authorized to execute a contract on behalf of the City with Chula Vista Blueprint Co. for furnishing of said REPRODUCTIONS pursuant to specifications therefor on file in the office of the City Clerk bearing Document No. 693607.
