

RESOLUTION No. 186041

BE IT RESOLVED by the Council of The City of San Diego as follows:

That the subordination agreement, executed by FRED ASHLEY and VIRGINIA J. ASHLEY, husband and wife as joint tenants, as Beneficiary, and THE FIRST NATIONAL TRUST AND SAVINGS BANK OF SAN DIEGO, a National Banking Association, as Trustee, bearing date September 29, 1965, wherein said parties subordinate all their right, title and interest in and to a portion of Lot 29 in Block 15 of DEL MAR HEIGHTS, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 157, filed in the office of the County Recorder of said San Diego County, July 8, 1887, to the easement for street purposes conveyed to The City of San Diego, through, along and across said property particularly described in said subordination agreement, be, and the same is hereby accepted on the conditions therein expressed;

That the City Clerk of said City is hereby authorized and directed to file the foregoing said subordination agreement for record in the office of the Recorder of San Diego County.
