

RESOLUTION No. 186049

BE IT RESOLVED by the Council of The City of San Diego as follows:

That the deed of JAMES V. SMITH, a married man as his sole and separate property, to an undivided one-half interest; and STEPHEN W. HAGAN, as Trustee under the Will of RUTH A. SMITH, also known as MRS. JAMES V. SMITH and MRS. J. V. SMITH, Deceased, to an undivided one-half interest, executed in favor of The City of San Diego, bearing date December 18, 1965, conveying to said City an easement and right of way for street purposes through, over and across portions of Lot 36 of The Highlands according to Map No. 284 filed in the office of the San Diego County Recorder March 16, 1887, as more particularly described in said deed, be, and the same is hereby accepted on the conditions therein expressed; and the lands therein conveyed as Parcel No. 1 are hereby set aside and dedicated as and for a public street and the same are hereby named BRINELL STREET; and the lands therein conveyed as Parcel No. 2 are hereby set aside and dedicated as and for a public street and the same are hereby named DAGGET STREET.

That the City Clerk of said City is hereby authorized and directed to file the foregoing said deed for record in the office of the Recorder of said San Diego County.
