

RESOLUTION No. 186149


BE IT RESOLVED by the Council of The City of San Diego as follows:

That the petition contained in Document No. 694546 for the grading, paving and installing curbs, gutters and sidewalks in GALVESTON STREET, between Lister and Kane Streets, and LISTER STREET, between Frankfort and Galveston Streets, is hereby granted.

That the City Engineer is hereby directed to furnish this Council with a description of the assessment district, and a plat showing the exterior boundaries of the district or lands in said City to be affected and benefited by and to be assessed to pay the costs, damages and expenses for the improvement of GALVESTON STREET, between Lister and Kane Streets, and LISTER STREET, between Frankfort and Galveston Streets, by grading, paving, installing curbs, gutters and sidewalks, and otherwise improving.


