

RESOLUTION No. 186165

BE IT RESOLVED by the Council of The City of San Diego as follows:

That the subordination agreement executed by CARL ACKERMANN, JR., HAZEL E. ACKERMANN, BEN F. MOORE, WILLIAM A. MILLIGAN, ELMIRA G. MILLIGAN, JAMES A. MILLIGAN and KATHERINE L. ORR, as Beneficiaries, and TITLE INSURANCE AND TRUST COMPANY, a California corporation, as Trustee, bearing date January 12, 1966, wherein said parties subordinate all their right, title and interest in and to portions of Lots 8 and 9, in Block 100 of PACIFIC BEACH in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 933 filed in the office of the County Recorder of San Diego County, November 9, 1904, to the easement for street purposes together with an easement for slope purposes, conveyed to The City of San Diego, through, along and across said property particularly described in said subordination agreement, be, and the same is hereby accepted on the conditions therein expressed.

That the City Clerk of said City is hereby authorized and directed to transmit the foregoing said subordination agreement to the Property Dept. for recording and further disposition.
