

RESOLUTION No. 186167

BE IT RESOLVED by the Council of The City of San Diego as follows:

That the deed of ALLEN L. BRANDT, a married man, as his sole and separate property, executed in favor of The City of San Diego, bearing date December 20, 1965, conveying to said City an easement and right of way for street purposes together with an easement for alley purposes through, over and across those portions of Lots 11, 14 and 15, Block 2, Loma Grande, according to Map No. 692 recorded in the office of the San Diego County Recorder November 23, 1891, as more particularly described in said deed, be, and the same is hereby accepted on the conditions therein expressed; and the lands therein conveyed as Parcel No. 1 are hereby set aside and dedicated as and for a public street and the same are hereby named WALNUT AVENUE, and the lands therein conveyed as Parcel No. 2 are hereby set aside and dedicated as and for a public alley.

That the City Clerk of said City is hereby authorized and directed to file the foregoing said deed for record in the office of the Recorder of said San Diego County.
