BE IT RESOLVED by the Council of The City of San Diego as follows:

That the bids for furnishing the City of San Diego with 16 TILT CAB TANDEM AXLE CAB AND CHASSIS and 1 TWO AXLE DRIVE (4x4) as follows:

1. International Harvester Co. for furnishing 15 Tandem Axle Cab & Chassis at a cost of \$9,440.48 each and one Tandem Axle Cab & Chassis Tilt Cab with Diesel Engine for a cost of \$12,054.13, F.O.B. Milwaukee, Wisconsin, for a total cost of \$153,661.33; terms net, plus sales tax;
