Grant, Deceased, executed in favor of The City of San Diego, bearing date November 4, 1964, conveying to said City an easement and right of way for street purposes, through, along and across portions of Pueblo Lots 1173 and 1174 of the Pueblo Lands of San Diego, as more particularly described in said deed, be, and the same is hereby accepted on the conditions therein expressed.

That the City Clerk of said City is hereby authorized and directed to transmit the said deed to the Property Department for recording and further disposition.

BE IT FURTHER RESOLVED, that Resolution No. 184186, adopted June 29, 1965, be, and the same is hereby rescinded.
