

RESOLUTION No. 186400

To improve and construct drainage structures in Smilax Street, Roselle Street, Begonia Street, Public Rights-of-Way in Lots A and C of Acre Lot 33 and Acre Lots 30 and 31, Sorrento Lands and Townsite and Calla Street; and change the official grade on Smilax Street and Roselle Street.

BE IT RESOLVED by the Council of The City of San Diego as follows:

That the proposed improvement within the limits mentioned in Resolution of Intention No. 185983 is hereby determined to be feasible and that the lands to be assessed therefor will be able to carry the burden of such proposed assessment, and that the public convenience and necessity require the proposed improvement, and that the Special Assessment Investigation, Limitation and Majority Protest Act of 1931 shall not apply.
