

APPROVING MAP OF MUIRLANDS WEST UNIT NO. 2 SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC PORTIONS OF A PUBLIC STREET AND THE WALKWAY DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO THE EASEMENTS AND ABUTTERS RIGHTS OF ACCESS AS GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by GUY W. WINTON, JR., Registered Civil Engineer, and entitled "MUIRLANDS WEST UNIT NO. 2 Being a subdivision of a portion of Pueblo Lots 1255 and 1256 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to map thereof by James Pascoe in 1870, filed in the office of the County Recorder, as Misc. Map No. 36.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, portions of a public street to wit: portions of Via Don Benito and the walkway for public purposes; and said portions of street and the walkway are hereby declared to be portions of a public street and the walkway dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of THE CITY OF SAN DIEGO, a municipal corporation, the easements, with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on said map, and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of THE CITY OF SAN DIEGO, a municipal corporation, any and all abutters rights of access in and to Fairway Road adjacent and contiguous to Lots 26 and 27, and Nautilus Street

adjacent and contiguous to Lots 70 through 82, all as granted and shown on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of a public street and the walkway are accepted on behalf of the public as heretofore stated; and that those certain abutters rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision, are accepted on behalf of THE CITY OF SAN DIEGO, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
