

RESOLUTION No. 186470

BE IT RESOLVED by the Council of The City of San Diego as follows:

That the deed of CLARENCE ADRIAN MEYER, a single man, and MAURICE M. MEYER, a married man as his sole and separate property, as joint tenants, executed in favor of The City of San Diego, bearing date January 17, 1966, conveying to said City an easement and right of way for street purposes through, over and across a portion of Lot 23, Tract 1380, being a Subdivision of Lot "H" of Encanto, according to Map thereof No. 1380 filed in the office of the County Recorder of San Diego, October 6, 1911, as more particularly described in said deed, be, and the same is hereby accepted on the conditions therein expressed; and the lands therein conveyed are hereby set aside and dedicated as and for a public street and the same are hereby named 65th STREET.

That the City Clerk of said City is hereby authorized and directed to file the foregoing said deed for record in the office of the Recorder of said San Diego County.
