BE IT FURTHER RESOLVED, that the expenditure of \$800.00 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for reimbursement to the subdivider of LANE SQUARE for the construction of additional improvements in PACIFIC HIGHWAY and GARNET AVENUE in said subdivision.
