

RESOLUTION No. 190496

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the deed of JOSEPH L. BONAMO and CHRISTINE R. BONAMO, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date March 20, 1967, conveying to said City an easement and right of way for street purposes through, over and across a portion of Lot 15, Block 5, Encanto Heights, in the City of San Diego, County of San Diego, State of California, according to Map No. 1063 filed in the office of the San Diego County Recorder June 6, 1907, as more particularly described in said deed, be, and the same is hereby accepted on the conditions therein expressed; and the land therein conveyed is hereby set aside and dedicated as and for a public street and the same is hereby named 64TH STREET.

That the City Clerk of said City is hereby authorized and directed to transmit the foregoing said deed to the Property Dept. for recording and further disposition.
