

ORDINANCE NO. 10593

JUN 3 1971

AN ORDINANCE INCORPORATING A PORTION OF LOT 13, RANCHO MISSION OF SAN DIEGO, AND LOT 37 AND A PORTION OF LOT 36, SONKA URBAN HEIGHTS (COLLEGE CREST ANNEXATION), IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO A-1-1 ZONE, AS DEFINED BY SECTION 101.0404 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Lot 13, Rancho Mission of San Diego, and Lot 37 and a portion of Lot 36, Sonka Urban Heights (College Crest Annexation), in the City of San Diego, California, within the boundary of the district designated "A-1-1" on that certain Zone Map Drawing No. B-2466, filed in the office of the City Clerk under Document No. 735611, be and it is hereby incorporated into A-1-1 Zone as defined by Section 101.0404 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
