The Budget for the expense of conducting the affairs of The City of San Diego for fiscal year commencing July 1, 1970, heretofore prepared and submitted to this Council by the City Manager and on file in the office of the City Clerk under Document No. 731769, as amended by Document No. 732462, and as further amended by Document No. 733431, is hereby adopted as the Annual Budget for said fiscal year. Said Budget is further amended in the manner set forth in that document on file in the office of the City Clerk as Document No. 736163."
