AN ORDINANCE AMENDING ORDINANCE NO. 10584 (NEW SERIES), AS AMENDED, TO CREATE THE CLASSIFIED POSITION OF SUPERVISING PLANNER AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Ordinance No. 10584 (New Series) of the ordinances of The City of San Diego, as amended, is hereby amended to create and establish the classified position of Supervising Planner.

Section 2. As the schedule of compensation for the position created in Section 1 hereof, the following standard rate number of the Table of Standard Rates of Pay established and adopted by Ordinance No. 10584 (New Series), as amended, of the ordinances of said City, is hereby adopted.

Section 3. The position of Supervising Planner shall be inserted in Exhibit B of Ordinance No. 10584 (New Series), as amended, under the general category of PLANNING AND COMMUNITY DEVELOPMENT before the position of Assistant to the Community Development Director.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
