

RESOLUTION NO. 201662 JAN 19 1971

APPROVING MAP OF VILLA PORTOFINO UNIT NO. 1 SUB-DIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE ALLEYS DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO THE EASEMENTS AS GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by E. F. COOK, Registered Civil Engineer, and entitled, "VILLA PORTOFINO UNIT NO. 1 Being a subdivision of a portion of the Re-subdivision of Lots 14, 15, 18 19 and 20 of Rosedale Tract in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 857, filed in the office of the County Recorder of said San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the alleys for public purposes and said alleys are hereby declared to be public alleys and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for open space over all of Lot 18 and the easement with the right of ingress and egress for the construction and maintenance of sewer and water facilities, together with a

16-foot pedestrian and non-motor vehicular easement all as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said alleys are accepted on behalf of the public as heretofore stated; and that the easement for open space, the easement with the right of ingress and egress for the construction and maintenance of sewer and water facilities, together with the 16-foot pedestrian and non-motor vehicular easement as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
