

RESOLUTION NO. 209950 FEB 26 1974

APPROVING MAP OF KEARNY VILLA PARK

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, Registered Civil Engineer, and entitled "KEARNY VILLA PARK Being a subdivision of a portion of Lot 72 of Partition of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to Partition Map made in the action entitled 'Juan M. Luco, et al vs. The Commercial Bank of San Diego, et al,' Superior Court Case No.348, on file in the office of the County Clerk, together with a portion of Kearny Villa Road as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Chesapeake Drive, and a portion of Kearny Villa Road for public purposes, and said street and portion of a street are hereby declared to be a public street and portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities as granted and

shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street and portion of a street are hereby accepted on behalf of the public as heretofore stated; and that those certain easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
