AN ORDINANCE AMENDING CHAPTER V, ARTICLE 8,
OF THE SAN DIEGO MUNICIPAL CODE BY ADDING
SECTION 58.07.1 RELATING TO PROHIBITION OF
SALE OF AEROSOL PAINT TO MINORS.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter V, Article 8, of the San Diego
Municipal Code be and the same is hereby amended by adding
Section 58.07.1 to read as follows:

SEC. 58.07.1 PROHIBITION OF SALE OF AEROSOL
PAINT TO MINORS

It shall be unlawful:

(a) For any person to sell, exchange, give
or loan, any aerosol spray can containing any substance
commonly known as paint, or containing any other
opaque liquid capable of being propelled by the
aerosol can, to any minor under the age of eighteen
(18) years, unless that person provides for the
supervision of the minor's use of such aerosol spray
can.

(b) For any person under the age of eighteen
(18) years to have in his or her possession any
aerosol spray can containing any substance commonly

known as paint or containing any other opaque liquid capable of being propelled by the aerosol can while upon public property or upon private property without the consent of the owner of such private property.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
