WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

George W. Hendrix	Water Utilities	\$5,000	Mr. Hendrix is an Equipment Operator II in the Utilities Systems Division. He suggested the use of a new method to renew water services. This is expected to save \$21,294 in the first year in costs for time, material and equipment.
Loren E. Southwick	Engineering and Development	\$2,500	Mr. Southwick is an Assistant Civil Engineer. He suggested eliminating the sand and seal requirements on trench resurfacing. This is expected to save \$21,000 in the first year in costs for material. This is a partial award pending a final 12 month review.
Betty S. Bixby	Auditor	\$1,150	Ms. Bixby is a Senior Account Clerk. She suggested modifying Form CE-456B, "Approved Subdivision application and Estimated Cost", to be an input document. This is expected to save \$7,609 in the first year in costs for time and material. This is a partial award pending a final 12 month review.
Vincent S. Fletcher	General Services	\$1,065	Mr. Fletcher is an Equipment Mechanic in the Equipment Division. He suggested that they rebuild the worn-out clutch housing for the Allison transmission instead of replacing it. This is expected to save \$7,102 in the first year in costs for time and equipment. This is a partial award pending a final 12 month review.
