BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for THE INSTALLATION OF FRIARS ROAD MEDIAN BARRIER AND TRAFFIC SIGNAL - SAN DIEGO JACK MURPHY STADIUM, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on SEP 30 1985 and bearing official Document No. W.O. 122415 be, and the same are hereby approved.
2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for THE INSTALLATION OF FRIARS ROAD MEDIAN BARRIER AND TRAFFIC SIGNAL - SAN DIEGO JACK MURPHY STADIUM.
5. That the expenditure, not to exceed \$745,745 from Gas Tax Fund 30219, CIP No. 52-328 FRIARS ROAD MEDIAN BARRIER is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
