APPROVING MAP OF VIEW RIDGE ANNEX.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Hans Peter Craig, Licensed Land Surveyor, entitled "VIEW RIDGE ANNEX being a subdivision of a portion of Lot 12 of the Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to the partition map thereof made in the action entitled "Juan M. Luco, et al, versus the Commercial Bank of San Diego, et al" on file in the office of the County Clerk of said County; together with Lots 369 through 371, inclusive, of View Ridge Unit No. 8, according to map thereof No. 11926, filed in the office of the County Recorder of San Diego County October 26, 1987; together with Lots 454 through 458, inclusive of View Ridge Unit No. 9, according to map thereof No. 12009 filed in the office of the County Recorder of San Diego County, February 4, 1988; also together with Lots 353 through 368, inclusive, of View Ridge Unit No. 7, according to map thereof No. 11843 filed in the office of the County Recorder of San Diego County, June 24, 1987, all being in the City of San Diego, County of San Diego, State of California, together with a portion of Terra Cotta Road as dedicated to public use. Including a drainage easement granted per map No. 11843, abandoned pursuant to the provisions of


Section 66499.20-1/2 of the California State Map Act," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Danawoods Court and Danawoods Lane, and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on the map within the subdivision and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets are accepted on behalf of the public as heretofore stated; together with the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
