

BE IT RESOLVED, by the Council of The City of San Diego, that the low bid of PAC WEST LAND CARE INC., is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF THE DESIGNATED MEDIANS, RIGHTS-OF-WAY, LANDSCAPED SLOPES AND PERIMETER BANKS WITHIN PARK VILLAGE ESTATES LANDSCAPE MAINTENANCE DISTRICT as may be required for a period of one (1) year beginning January 1, 1993 through December 31, 1993, per prices on file in the Purchasing Department, for a total estimated annual cost of \$48,007.97; terms 2% 20 days, with options to renew contract for four (4) additional one (1) year periods with increases not to exceed 6% of the prices in effect in each prior period.

BE IT FURTHER RESOLVED, that in the event the Contractor does not perform to specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder and to subsequent bidders, if necessary, until a bidder is found who performs to specifications.
