AN ORDINANCE AMENDING THE EFFECTIVE DATE OF THE PREVIOUSLY APPROVED SECOND UPDATE TO THE LAND DEVELOPMENT CODE.

WHEREAS, on January 9, 2001, the City Council adopted Ordinance No. 18910 (NEW SERIES) approving amendments to the Land Development Code [LDC] as part of the second quarterly update of the LDC [the Amendments]; and

WHEREAS, Ordinance No. 18910 provided in Section 9 (for provisions requiring certification as Local Coastal Program [LCP] Amendments) that the Ordinance would be in force and effect on the date it became effectively certified by the California Coastal Commission [the Commission]; and

WHEREAS, the Amendments were submitted to the Commission for certification as part of the City of San Diego's LCP; and

WHEREAS, the Commission certified the Amendments requiring LCP certification, without any modifications as provided in California Coastal Commission reports dated February 27, 2001 (titled "CITY OF SAN DIEGO DE MINIMUS LOCAL COASTAL PROGRAM AMENDMENT NO. 7-2000 (Land Development Code/Second Quarterly Update)") and April 16, 2001 (titled, "STAFF RECOMMENDATION ON CITY OF SAN DIEGO MAJOR AMENDMENT NO. 6-2000-B (Implementation Plan Modifications - Second Quarterly Update)"), except for the amendments relating to floodplain regulations (appearing in Sections

62.0423, 113.0103, 126.0402, 126.0502, 126.0504, 129.0602, 131.0205, 142.0135, 142.0230, 143.0110, 143.0111, 143.0130, 143.0145, 143.0146 and Table 143-01A) which the Commission will consider at a future hearing, and amendments relating to previously conforming uses in the Coastal Overlay Zone (Sections 127.0106 and 127.0107); and

WHEREAS, the City Council finds it to be in the interest of the health, safety and welfare of the citizens of San Diego that the LDC amendments take effect at the earliest possible date; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the Land Development Code amendments contained in Ordinance No. 18910 (NEW SERIES) shall take force and be in effect on the effective date of this ordinance except for the amendments relating to floodplain regulations (appearing in Sections 62.0423, 113.0103, 126.0402, 126.0502, 126.0504, 129.0602, 131.0205, 142.0135, 142.0230, 143.0110, 143.0111, 143.0130, 143.0145, 143.0146 and Table 143-01A) and the amendments relating to previously conforming uses in the Coastal Overlay Zone (Sections 127.0106 and 127.0107), which amendments shall take force and be in effect on the date effectively certified by the California Coastal Commission as Local Coastal Program amendments.

Section 2. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
