DATE OF FINAL PASSAGE DEC 17 2014

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$6,000 TO OCEAN BEACH COMMUNITY DEVELOPMENT CORPORATION FOR VETERANS PLAZA, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, Council Policy 100-06, "City Council Funding of Community Projects, Programs and Services" (CPPS), provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural or recreational needs which serve a lawful public purpose; and

WHEREAS, Ocean Beach Community Development Corporation has requested funding for Veterans Plaza, intended to be a historic and cultural resource honoring military history; and

WHEREAS, the requested funding will be used to pay costs of the project, including a scale model replica of Veterans Plaza and a display to assist in fundraising; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06, "Community Projects, Programs and Services;" and

WHEREAS, Council District 2 recommends an allocation of \$6,000 to Ocean Beach Community Development Corporation for the purposes set forth herein attributed as follows: Council District 2 - \$3,500, and Council District 9 - \$2,500; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described herein is made for a public purpose.

BE IT FURTHER RESOLVED, that the Council hereby waives the following provisions in Council Policy 100-06: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased," and "Funds shall not be used for . . . fundraising activities;" and

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, an Agreement with Ocean Beach Community Development Corporation in an amount not to exceed \$6,000 for the project described herein, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 309378.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$6,000 from the Community Projects, Programs and Services budget Fund No. 100000, as follows: \$3,500 from Cost Center 1102110002, and \$2,500 from Cost Center 1109110009, to provide funds for the above-referenced agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.




