DATE OF FINAL PASSAGE DEC 10 2018

AN ORDINANCE AMENDING CHAPTER 2, ARTICLE 7, DIVISION 35 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 27.3564, RELATING TO ETHICS.

WHEREAS, the City of San Diego (City) Ethics Ordinance (Ethics Ordinance), codified at Chapter 2, Article 7, Division 35 of the San Diego Municipal Code, was adopted on April 29, 2002, by Ordinance No. O-19055 N.S.; and

WHEREAS, the Ethics Ordinance includes provisions related to the misuse of a City official's position and City resources; and

WHEREAS, City Officials and City staff are entrusted with confidential information so they can best protect the people they serve; and

WHEREAS, the City must preserve the confidentiality of certain City documents and information to protect the City's position in negotiations, employee relations, litigation, and to avoid or minimize legal and financial risk to the City; and

WHEREAS, failure to preserve the confidentiality of such documents and information, whether intentional or not, adversely impacts the City Attorney's ability to communicate with her client, chills the City Council's ability to engage in deliberations, and compromises the City's position with potentially dire consequences to the City and taxpayers; and

WHEREAS, the amendment in this ordinance prevents abuse of power by limiting disclosure of the City's confidential information to circumstances clearly authorized by law;

NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That Chapter 2, Article 7, Division 35 of the San Diego Municipal Code is amended by amending section 27.3564, to read as follows:

§27.3564 Misuse of City Position or Resources

(a) through (d) [No change in text.]


(e) It is unlawful for any current or former *City Official* to use or disclose to any *person any confidential information* he or she acquired in the course of his or her official duties, except as authorized by law.

(f) [No change in text.]

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
