A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AN AGREEMENT WITH DELOITTE CONSULTING LLP TO PROVIDE APPLICATION DEVELOPMENT, MAINTENANCE, AND SUPPORT FOR THE GET IT DONE SYSTEM AND SALESFORCE PLATFORM.

WHEREAS, the Get It Done online portal connects citizens with a variety of services and supports critical City operations across multiple departments; and

WHEREAS, application development and maintenance are necessary to support, maintain, enhance, and expand the Get It Done system; and

WHEREAS, the existing Get It Done support and maintenance contract, awarded to Deloitte Consulting LLP in 2018, expires on July 31, 2020; and

WHEREAS, a competitive procurement with a request for proposals was issued and evaluated, resulting in the selection of Deloitte Consulting LLP as the best vendor to provide the necessary services; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is hereby authorized to execute a two-year agreement with three optional one-year extensions with Deloitte Consulting, LLP to provide application development, maintenance, and support for the Get It Done system and Salesforce platform in a total amount not to exceed \$20,480,337.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$20,480,337 over the full term of the Contract, including any options to

renew, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal years, and contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
