A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO ALLOCATING FUNDING FROM THE FISCAL  
YEAR 2021 U.S. DEPARTMENT OF HOUSING AND URBAN  
DEVELOPMENT COMMUNITY DEVELOPMENT BLOCK  
GRANT PROGRAM TO THE TECHIRE PROGRAM,  
APPROVING AN AMENDMENT TO THE FISCAL YEAR 2021  
ANNUAL ACTION PLAN AND TAKING RELATED ACTIONS.

WHEREAS, the City of San Diego (City) is an entitlement jurisdiction that annually receives federal funds through the U.S. Department of Housing and Urban Development (HUD) Community Development Block Grant (CDBG) entitlement grant program; and

WHEREAS, the Fiscal Years 2020-2024 Consolidated Plan (Consolidated Plan), adopted by the San Diego City Council (Council) by San Diego Resolution No. R-312442, effective April 26, 2019, assesses community development and affordable housing needs and identifies seven (7) high priority goals, and one (1) additional goal related to the Housing Opportunities for Persons With Aids Program for Fiscal Year 2020; and

WHEREAS, the City's Fiscal Year 2021 Annual Action Plan (FY21 Action Plan), is part of and implements the second year of the Consolidated Plan and serves as the City's application to HUD for entitlement grant funds, identifying the projects and programs to be funded by the City in Fiscal Year 2021; and

WHEREAS, effective May 21, 2020, Council adopted Resolution No. R-313042, approving the City's FY21 Action Plan; and

WHEREAS, as part of its approval of the Fiscal Year 2021 CDBG allocations, Council removed allocations to the San Diego Housing Commission for the Housing Navigation Center operations and to the San Diego Workforce Partnership for the TechHire Program and requested additional information; and

WHEREAS, Council now desires to allocate Fiscal Year 2021 CDBG funding for the TechHire Program; and

WHEREAS, a five (5) day public comment period will be conducted following Council consideration of this item and will be publicized on the City's Community Development (CDBG) webpage and via email distribution lists; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Chief Financial Officer is authorized to appropriate and expend \$500,000 in FY 2021 Unobligated CDBG Program, Fund 600000 Grant 10000003-2021 to the San Diego Workforce Partnership for the ongoing operations of the TechHire Program, contingent upon the Chief Financial Officer certifying that the funds are available.
2. The Mayor, or designee, on behalf of the City, is authorized to negotiate and enter into agreements or amendments to existing agreements, as applicable, with the San Diego Workforce Partnership, providing for the expenditure of the allocated funds for the purpose for which they were allocated, contingent upon the Chief Financial Officer certifying that funds are available.
3. The Mayor, or designee, on behalf of the City, is authorized to amend the FY21 Action Plan, as applicable, to ensure that the approved \$500,000 FY 2021 CDBG allocation to the San Diego Workforce Partnership for the TechHire Program, and all public comments about such amendment received by the City during the public comment period are included in the final

amendment, and further authorize the Mayor, or designee, to submit the final amendment to HUD for approval.
