WHEREAS, in accordance with San Diego Charter section 69, on June 30, 2020, the City Council adopted the Appropriation Ordinance to provide for the appropriation and expenditure of funds for the Fiscal Year 2021; and

WHEREAS, the Mayor and the City Council desire to provide for the effective administration of the Fiscal Year 2021 Budget; and

WHEREAS, the Independent Budget Analyst, in consultation with the Mayor, has prepared a Statement of Budgetary Principles, on file with the City Clerk as Document No. R-313209 which acknowledges the duties of the Mayor as Chief Budget Officer and Chief Fiscal Officer of the City, and the City Council as sole legislative and lawmaking body of the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Council hereby adopts the Statement of Budgetary Principles.


