A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF AS-NEEDED SAP CONSULTING SERVICES AGREEMENTS WITH AMICK BROWN, LLC, ATOS IT SOLUTIONS AND SERVICES, INC., CGI TECHNOLOGIES AND SOLUTIONS, INC., CHARTER GLOBAL, INC., DELOITTE CONSULTING, LLP, EJANGAR, INC., EPI-USE AMERICA, INC., GENIUS BUSINESS SOLUTIONS, INC., IBM CORPORATION, KASTECH SOLUTIONS, LLC, LABYRINTH SOLUTIONS, INC., MCKINSOL CONSULTING, INC., NTT DATA, INC., PHOENIX BUSINESS, INC., SIERRA DIGITAL, INC., SMARTSOFT TECHNOLOGIES, INC., SOFT HQ, INC., TACHYON TECHNOLOGIES, LLC, TATA CONSULTANCY SERVICES LIMITED, THE PELOTON GROUP, LLC, UST GLOBAL AND V3IT CONSULTING, INC.

WHEREAS, the City of San Diego (City) uses SAP's enterprise resource planning software to assist with managing complex services in the areas of Finance, Logistics, Personnel, Payroll, and other areas; and

WHEREAS, SAP requires ongoing support and configuration similar to other information technology systems; and

WHEREAS, on March 25, 2020, the City issued RFP No. 10089655-20-B for SAP Consultant Services and identified 22 consulting firms with which it wishes to contract; and

WHEREAS, this is a request to issue 22 as-needed contracts for such services, each with a five-year term, with a cumulative not to exceed amount totaling \$21,000,000 for all 22 contracts;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is hereby authorized to execute separate contracts between the City and Amick Brown, LLC, Atos IT Solutions and Services, Inc., CGI Technologies and Solutions, Inc., Charter Global, Inc., Deloitte Consulting, LLP, Ejangar, Inc., EPI-USE America, Inc., Genius Business

Solutions, Inc., IBM Corporation, Kastech Solutions, LLC, Labyrinth Solutions, Inc., McKinsol Consulting, Inc., NTT Data, Inc., Phoenix Business, Inc., Sierra Digital, Inc., SmartSoft Technologies, Inc., Soft HQ, Inc., Tachyon Technologies, LLC, Tata Consultancy Services Limited, The Peloton Group, LLC, UST Global and V3it Consulting, Inc. to provide as-needed SAP consulting services to the City, under the terms and conditions set forth in the contracts on

file in the Office of the City Clerk as Document Numbers RR- 313244 -1,

respectively, with a total, cumulative amount not to exceed Twenty-One Million Dollars (\$21,000,000) for all 22 contracts during a five (5) year term.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$21,000,000 over five years for the purpose of funding the 22 as-needed contracts for SAP consultant services, contingent upon the City Council's approval of the applicable fiscal year's Appropriation Ordinance and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.


