DATE OF FINAL PASSAGE JUN 17 2021

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO SUSPENDING THE REQUIRED CONTRIBUTION
TO THE INFRASTRUCTURE FUND FOR FISCAL YEAR 2022.

WHEREAS, on April 20, 2021, the Mayor's proposed budget for Fiscal Year 2022
(Proposed Budget) was presented to the City Council (Council); and

WHEREAS, on May 20, 2021, the Mayor's May revision (May Revision) to the
Proposed Budget, released on May 18, 2021, was presented to the Council sitting as the Budget
Review Committee; and

WHEREAS, pursuant to San Diego Charter (Charter) section 77.1, the amount of the City
of San Diego's (City's) annual general fund contribution to capital projects constituting
"Infrastructure" (as defined in Charter section 77.1) budgeted in a given fiscal year must be
greater than or equal to the amount budgeted for same in Fiscal Year 2016 (Required
Contribution); and

WHEREAS, pursuant to Charter section 77.1, if the Mayor's proposed budget in a given
fiscal year requests the suspension of the Required Contribution, the Council may approve such
suspension by a two-thirds vote; and

WHEREAS, the May Revision includes the suspension of the Required Contribution;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Required Contribution is suspended for Fiscal Year 2022.
