A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN AMENDMENT TO THE CONTRACT WITH THE CENTER FOR EMPLOYMENT OPPORTUNITIES, INC. RESULTING FROM REQUEST FOR PROPOSAL NUMBER 10089597-20-B, CLEAN SAN DIEGO SERVICES; AND RELATED ACTIONS.

WHEREAS, the City of San Diego (City) issued Request for Proposal (RFP) Number 10089597-20-B, Clean San Diego Services, on or around November 7, 2019, for as needed illegal dumping and litter removal and transient camp abatements and accepted the proposal submitted by the Center for Employment Opportunities, Inc. (Contractor); and

WHEREAS, on February 4, 2020, the City entered into a contract with Contractor to provide services as set forth in RFP No. 10089597-20-B (Contract), in an amount not to exceed \$2,000,000; and

WHEREAS, the Contract provides for a term of one (1) year with the option to extend the Contract for four (4) additional one (1) year periods; and

WHEREAS, the total compensation not to exceed \$2,000,000 in the Contract was determined based upon the initial one-year contract term; and

WHEREAS, the City and Contractor want to enter into a First Amendment to increase the total compensation under the Contract from \$2,000,000 to an amount not to exceed \$11,596,000, to allow the City the opportunity to exercise options to extend the Contract; and

WHEREAS, all other terms and conditions of the Contract will remain the same; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, the First Amendment to the Contract with the Center for Employment Opportunities, Inc. for waste removal services and transient camp abatements, increasing the total compensation under the Contract from \$2,000,000 to an amount not to exceed \$11,596,000.

2. That the Chief Financial Officer is authorized to expend a cumulative amount not to exceed \$11,596,000, from the General Fund, Fund 100000, Clean SD, Business Division 211514, over the term of the Contract for the purposes of funding the Contract with the Center for Employment Opportunities, Inc., contingent on the adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer first furnishing one or more certificates, demonstrating that the funds are, or will be, on deposit with the City Treasury.
