A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT
BETWEEN VENITA MARIE HOLLENBECK AND THE CITY
OF SAN DIEGO

WHEREAS, on October 25, 2019, VENITA MARIE HOLLENBECK filed suit against the City of San Diego alleging personal injury arising from a trip and fall on a raised sidewalk on the west side of Cable Street in Ocean Beach, just south of Saratoga Avenue on October 25, 2017. The suit is entitled *Venita Marie Hollenbeck v. City of San Diego*, San Diego Superior Court Case No. 37-2019-00056773-CU-PO-CTL; and

WHEREAS, in Closed Session on May 18, 2021, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 7, 8, and 9; Nays, None; and Absent 6, approved the Settlement for an amount consistent with the amounts set forth below;

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$160,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury complaint filed by Plaintiff Venita Marie Hollenbeck.

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$160,000.00 from Public Liability Fund No. 720045, for the purpose of settling this claim.


